## President's report:

Thanked Gary Bergman for the help he is giving with his fried computer.

Danny introduced our lawyer Steve Fox. There have been developments that we need to be aware of. Steve reviewed that we had to go to arbitration. We asserted a claim. The contractor had 30 days to request mediation. Contractor was not cooperative. The claim was dismissed and we filed suite in Middlesex County. They filed third party defendant. Mitch Frumkin has been named. We see this as frivolous. Deposition notices have also been served. We can control our side but not what they are doing \$320,690 is what we are looking at. We could win the case and not collect the money or incur legal fees that cut into this amount. If we settle, we are more likely to get money. There are three key times to settle, the last of which is before trial. We have spent a little less than \$10,000.

Mitch's company is also being sued and we need to decide whether we are going to cover his deductible. Mitch is also personally being sued but he is covered under our synagogue policy.

Lengthy discussion followed.

Paul Zankel suggested that we appoint a legal committee to continue on with this discussion since the lawsuit will continue after this board has changed.

## Cantor's report:

Cantor has been participating much more actively in committees at BT and is very proud of the efforts of these committees. Many of our programs are being attended by more and more people. We should keep our vision as we go forward.

## Mark Kasdin financial secretary:

437 members, 273 fdpe, 85 on special. we will probably be dropping 12 families. We have 17 new families who have joined since last April, 1 has resigned according the Ruth Anne. Cantor wants to know whether the Rabbi gets involved with families on

special. Kasdin feels that these families have just chosen not to pay without sending in a letter. The other 8 will be spoken to.

## **Motion by Mark Jiorle:**

#### In it's final form

In order to promote and nurture Jewish Education, we move that children whose parents are not members of congregation B'nai Tikvah be eligible to attend religious school and have a bar/bat mitzvah under their grandparent's membership given the following conditions:

- 1. Written permission must be received by the parents
- 2. Grandparents are members in good standing
- 3. Grandparents will not be eligible for senior membership rate
- 4. Standard fees apply for grades K through 2 and Hebrew High School
- 5. Standard fees plus 30% apply for grades 3 through 7
- 6. The bar/bat mitzvah fee for these children will be twice the standard fee

Seconded by Marc Dillman

We currently have one family in this position and with down the line. A previous president allowed these children to enroll in the religious school. Now we must make decisions to move forward.

## **House & Grounds**
