Minutes from board meeting April 3, 2006 Congregation B'nai Tikvah

Meeting called to order by president Danny Greenberg at 8pm. Motion to accept minutes by Cindy Gittleman. Seconded by Aaron Rosloff vote; 13 in favor **Motion passes**

President's report:

Budget committee has started meeting. Any ideas for new revenue sources will be greatly appreciated. Anyone who has liner item authority, get that info in.

Strategic membership task force to reach out to people who we have not reached out to yet. Info will be presented at next board meeting.

Capital campaign new round about to get started. To reach out to people that we missed the first time around.

Operation promise this Sunday. Speaker will be presenting. Danny has her bio. Encouraged all board members to attend. Ethiopian woman who moved to Israel.

Thank yous went to; everyone who made this past weekend a success, thanked Ruth Anne and her committee. And to everyone whose plaques we dedicated.

Aaron Rosloff for the ark in the bet midrash, it came out beautifully and is a great tribute to Millie.

Thanks to Gary for installing the monitor, it was up and running this past weekend. instructions are on the website.

Casino night committee, it was a terrific success. Raised \$19,000.00. Allusion specifically thanked Gary Warner who worked so hard.

New business:

Motion by Marc Dillman regarding refinancing.

Cancel the existing \$400,000 credit line (interest only) loan. Establish a fully amortizing loan for \$400,000 which will term out at approximately 210 months (October, 2023). Agree to a swap agreement which will fix the interest rate on the loan until its maturity, which will require an independent financial advisor to sign off on the Board's understanding of the swap agreement.

Seconded by: Ruth Anne Koenick

Marc gave background and explained commercial loans. there is no such thing as a 30 year fixed loan for commercial loans. a swap agreement. The bank sells off our interest rate to someone else, it allows us to get the long term rate. There are prepayment penalties.

Vote: 20, no opposed. **Motion passes**

Old business:

Arie: nominating committee. Midterm election. Arie would like to get in place who will be the next president. Board should recommend names for the board. Mitch feels that everyone on the executive board is eligible to be president and unless they do not want to serve they should say so.

Cindy Gittleman: status of revenue. Revenue came in at \$2400 for March \$1612 projected for April. Has some contracts.

Cindy presented a cake to Paul Zankel as a thank you for his many years of working on Hakol. Cindy introduced Phil Welsher as the new editor as well as Rachel Rodriguez.

Mitch Frumkin: status of arbitration. Fee was made to American arbitration association. Selection of arbitrators taking place and then moving forward with that. Bond: items are done that township thought wasn't done. Other items being done. We should see that money soon.

Reports:

Cantor: March adult Torah class has begun and is well attended. There are also more children reading Torah when there is no bar or bar mitzvah.

Sons of Tikvah tour continues. Performed at Somerbrook Purim party. Looking for more opportunities.

Rabbi farewell dinner, being chaired by Cantor and Stacey. Invitations being mailed shortly. Theme is hockey. Ad journal book is a budgeted item and everyone is encouraged to solicit ads. Lewish Sheller is doing the printing for free.

Mark Kasdin - Financial secretary: 435 members, 281 FDPE. 89 on special arrangements.

Marc Dillman: Report distributed and highlights were reviewed. Borrowing heavily into our accounts right now. We borrowed to pay for the roof.

Quick estimates were made at the budget committee and it was determined that we will not have a positive variance at the end of the fiscal year. Budget line items need to be. Give Marc projected expenses for the remainder of the year.

We did receive our actual electric bill and that has been paid.

Marc asked that all vps use his new form when turning receipts in for reimbursements.

VP reports: religious school tuition, 19 families had balanced at the beginning of the year. That number is much higher than in the past. Phone calls were made. Danny and Jeff wrote a letter in February, telling how much needed to be paid. 3 or 4 families then paid. 15 families were told they could not attend religious school if money was not paid. 7 more paid. left 9. 2 had upcoming bnai mitvzot. 1 had lessons about to begin. 1 paid, 1 paid almost all, discussion with the other family. 2 are no longer attending religious school. 4 left, children still going to school. We have had to go in and pull the children, the parents have just dropped the children off and have left. Mark Jiorle suggested that we sell those children on ebay.

Jeff wants us to understand that the membership subsidizes the tuition by 30-35%. If anyone hears discussion that we are forcing certain situations we should explain to people what our financial situation is. We cannot afford to carry these families. They should be paying their fair share that they agreed to pay. Frank wanted to if we could send these people somewhere for the child to get the education. Cantor feels that these people want to stay here.
