Meeting called to order at 8pm by president Arie Behar

1 correction to minutes from March board meeting, Hadas was at that that meeting. Motion to accept minutes with correction by Jeff Cadoff, seconded by Ruth Anne Koenick

In favor: 10 against 0, abstain1

Arie just got back from Israel, stayed with friends in Ramla and had a great trip.

New Business: Mitch Frumkin got price from alarm company to add to the expansion, this was not in the original budget.

Motion by Mitch:

To approve the proposal from ADT to install alarm system in the new building at cost of \$5,455, which will include motion detectors, doors. There will be an annual charge to service and maintain the system at a cost of \$1764

Seconded by Jeff Cadoff.

Janice feels that we should get Ben Shapiro involved because he did all the research for our existing building. Hadas has been involved with this and can answer any questions. This is a burglar alarm not a security system.

Motion withdrawn so that Hadas can do further research.

Danny: Adding position in the office. Originally a full time highly paid position, proposed over one year ago. Our finances then were not what they are now. Does not feel it is appropriate to hire someone at that level now. Proposing a part time 20 hours per week employee at \$20 per hour.

Vote to decide whether we should continue discussion with professionals in the room. 10 in favor 5 against.

Motion by Danny Greenberg:

To approve the job responsibility description for this new position, which is to explore creative ways of marketing the use of our building for sports, recreation, fitness, educational, religious, cultural and entertainment activities (and anything else you can think of) and execute on those plans.

Seconded by Gary Warner

Marc Dillman pointed out that we do not have the money in the budget to cover the expense of this position. But, we do need to invest in his position to generate revenue. Arie feels that this cannot be a volunteer position.

Mitch feels that we have to take this step.

Motion withdrawn until later because it may tie into a discussion later tonight.

Gary Warner: Dinner dance report. A huge success. Many people attended who had not been at previous events. 14 of the 17 past presidents attended. It was a fun filled evening. We raised in excess of \$28000. We had almost 150 advertisers. \$3,000 will

be going towards the opening of the new wing. We therefore netted over \$25,000. The gifts that were presented to the past presidents were beautiful and had a lot of meaning. Positive feedback from the presidents. Next year's event will probably be a casino night, Gary has agreed to chair the event.

Janice: Social action met last week and had an idea to have an artist from our synagogue do a mosaic drawing that people could contribute to, for a cost, the proceeds to go toward a yet undetermined charity.

Motion by Janice:

To allow social action committee to develop a piece of artwork, board approved to put on the wall of the new wing.

Seconded by Cindy Gittleman.

Discussion: This wall has been designated as the donor wall. Rabbi suggested that this be done as a freestanding piece of art that could be hung anywhere.

Rabbi suggested that we find out what was done in the past as far as plaques go.

Janice needs clarification as to whom she should talk to.

Kasdin pointed out that level of recognition for anyone who gave over \$1800.

Mark Kasdin was asked by Arie to form a committee to decide if there will be a donor wall and where it will be.

Rabbi suggested we use the existing donor wall.

Cindy thinks that we can combine the two ideas.

Motion withdrawn.

Old Business: Last month Marc Dillman asked how the rooms were going to be used. Janice came with a floor plan,

Jeff questioned the position of the Sisterhood storage spot, that it really needs to be used for stage storage.

Question about the size of the youth lounge.

Reports: Financial secretary, Mark Kasdin. 449 members, 85 on special arrangements, 295 DPE.

There are a few members who wait until the last minute to pay their bill. We need the money on an ongoing quarterly basis. Can we tack on late charges to our dues? Ruth Anne wants to know what our gains and losses would be. Kasdin is not sure. This is about 12 families. Janice suggested an early bird payment, but it was felt that this would be a bookkeeping nightmare. Suggestion that we take credit card information so that we can just collect this money.

Kasdin will let us know demographics of the families who are late in paying.

Past president's report: Mitch Frumkin. Expansion. Floor has been started in multi purpose room, plumbing fixtures going in, by end of next week we should be done with the building. This doesn't include the CO. Once the multipurpose room floor has been laid it cannot be walked on for seven days.

Gary Bergman: Phenomenal attendance at adult ed programs in March. Rabbi will be giving a 15-step program for two weeks about Seders.

Membership: Cindy Gittleman. 136 members invited to the Chai member club. These names will be listed in Hakol as well.

VP administration, Danny.

Roof is repaired as needed.

What's going on with board installation, Arie wanted to know. June 24th.

Treasurer' report: Marc Dillman. Reviewed report.

House and grounds is over budget and cannot spend any more money unless they come to the board first.

Invoices were paid that put the budget over. Mitch feels there were administrative circumstances that couldn't have been foreseen.

Website/Communications

Monthly Report March 2005 Date of Report: April, 2005

Construction:

In order to give a better idea of how the construction has been proceeding I have prepared the following list of the primary contractors and their percentage complete along with a commentary regarding the project schedule and any anticipated extras. Also presented is a list of work still not under contract.

The heat is on for all of the building. The vinyl flooring has been installed in all classrooms and should be finished in all areas except the entrance area by the April 8th. The stage floor has been installed and still needs to be sanded and finished. The handicap ramp adjacent to the stage has been installed. The ceramic tile in the bathrooms has been installed and the bathroom fixtures have been delivered and will be installed the week of April 4th along with the bathroom partitions and counter tops. The water connection at the rear of the building was finalized this past week. The sprinkler system is complete and has been pressure tested. The HVAC system is complete and is in the process of being balanced. It has been determined that the fire detection system price was not included in the original contractor's budget. This work has been awarded to ADT security and is in the process of being installed.

In response to the Attorneys letter to the Contractor, he has contacted us about setting up a meeting to talk about our claim. Our Attorney has sent a letter to the contractor in an attempt to expedite the meeting. In parallel, all information has been sent to the Architect for certification of the amount of our claim.

Feedback Committee

The Feedback Committee has not met as we have not received any feedback from the Congregation although we have been advertising in Hakol.

Nominating Committee

The Nominating Committee has met a number of times and will be presenting the following slate at the Congregational Meeting for the next Executive Committee. We are meeting again at the end of April to work on our recommendations for the open Board positions. If anyone has any suggestions, please let me know.
