#### 2. Jeff Schwartz:

Here to report on Cantor's installation, which was held June 9th. There was a dinner, followed by mincha, then the program, then maariv and finally a reception.

It was very moving. Thanks you to the Board, to Arie, to Ruth Anne, to Stacy and to Elliot for helping bring it about.

On the financial side of it, we had appropriated \$2,045 for the event in January. We ran a little over budget. The total spent for the event was \$2,483.

The reason we went over was because we comped more people than we thought we would. Moved [H. Finkelstein, second by J. Baer] to allocate an additional \$438 to cover the additional amount. Motion carries [12 yes, 0 no, 3 abstain].

Also: we approached some of larger donors who are behind on their pledgesfor the new building. One indicated that they are working on it. Another said that he wants to donate stock.

K. Zimmerman: what about smaller donors? They weren't called.

### Education [H. Schneider]

Not much. Youth commission has met. Toby Ehrlich & Adrianne Ross will co-chair. Oversees Kadima & USY.

### Administration [A. Behar]

- High holidays coming fast. Asked Mark Binder & Larry Cohen to chair everything inside the sanctuary. They are gathering names for honors. Please talk to them. Marty Abschutz will be in charge of everything outside the sanctuary. Security, ushers, etc. We have policemen in the budget. Possibly guards inside the building as well.
- · We are changing the format of all the solicitations at services.
- We have started the process of looking for an assistant to the clergy. Ad was in home news. Will also be in Jewish State. We will use the process established by John Wolf.
- · Cyndi Kleinbart looking at procedures of room rentals, e.g., putting on musicals, etc.
- · Motion [by A. Behar, second by M. Sherman]:

As stated in our by-laws we are required to have Board approval before into any contract with a value of more than \$2,000. Therefore we request Board approval to enter into a lease agreement to lease two machines. The first is the Mailing System Office Right and the second is the Mailing System W-650. These units will allow us to process mail more efficiently, including folding, stamping, assigning bar codes, prints addresses and envelope stuffing. The total monthly cost of these machines is \$313.00.

- G. Bergman: how does Hadas feel? We need this. It is most cost effective.
- A. Behar: bar codes reduce the postage. Pitney Bowes says we'll save \$2K. Hadas: we will save money, but we don't know how much.
- · K. Zimmerman: maintenance? Included.
- G. Tinkel: size? Relatively small. Each one about the size of a printer.
- J. Baer: is there security? It's not a postage meter.
- R. Koenick: how long an agreement? 5 yrs. Penalty for early? Don't know.
- M. Dillman: What staff is needed to use this? Nobody new.
