- 4. Rachel Shaneson (Scrip Chairperson): big thanks to the scrip committee and the board. We have sold \$104K worth of scrip. Asking for help would like board members to take a shift on Sunday mornings. There are 2 shifts: 8:50 AM to 10:30 AM & 10:30 AM to 12:15 PM. You will always be paired with an experienced person. Please call at home to RSVP or email scrip@bnaitikvah.org. Please buy!! Our goal was achieved: over 100 families participate and over \$100K in sales. Job well done.
- G. Bergman we made money on the calendar this year. Commercial ads way up, individuals down. \$2100 revenue, wholesale printing, should net out between \$750 \$1,000. Thanks to Gary he does this pretty much on his own.

Old Business [All]

Expansion:

We got the word that our request re wetlands has been recorded by the state and they have assigned it. Jeff Cadoff's company has someone who knows people in the DEP; if we haven't heard anything by August 15th, we will try to use this resource.

- M.Gaynor: Are the builders wiling to hold prices? Yes (as of July 15th for February prices).
- J.Marcou: People are demanding info can we get something out to people? We'd like to wait a week or so to see if there is any good news re wetlands..

Administrator's Report

High holiday preparations are in full gear. Letters have gone out to congregants – tickets will go out end of the week. We are preparing security. Probably fewer chairs than usual – 30–50 fewer people will be accommodated. We are adding temporary handicapped spots in the lot. Also on the search for additional help in the office: there were 9 applications – 3 interviews. 2 good. Second round on Tuesday.

Vice-Presidents Reports

Administration [L. Cohen]

Letters for honors at High Holidays going out this week. Please get additional names in. The appeals changed somewhat – spread out over the three days. C. Kleinbart: Is there an Israel Relief Fund appeal? There will be a Federation appeal that includes it.

Ways & Means [M. Sherman]

Gary Warner will chair major fundraiser – assembling a creative team this Thursday including some veteran fundraisers and creative people. Whiteboard some ideas; drill them down to several key ideas. Meeting is open to all please come.

School & Youth [H. Schneider]

New Kadima advisor – Kfir Weinraub. Rutgers student. USY planning "pizza in the hut" and an ice cream party.

- N. Jackenthal: is there a collection procedure in place for nonmember families that owe money to the nursery school? We have a family in this situation. Billing for nursery is done outside synagogue. Normally, they'd be held back from Hebrew school, but these are non-members. We can send a lawyer letter.
- J. Marcou: Junior Congregation commitment if not met, what happens? They have to do it over summer. If not, they are held back. There are two families in that situation now at least one is coming over summer.
- N. Jackenthal: Some nursery school parents have approached about doing feedback about Fran. Do we do a performance evaluation and can the parents participate. H. Schneider: her contract has one more year to go. Will consider all ideas for evaluation. R.A. Koenick: have to make sure it's not just negative feedback needs to be constructive. C. Kleinbart: everyone should be surveyed. G. Bergman: Parent Advisory Committee? Acts like a PTA, not a school board.

Financial Report [G. Tinkel]

2 classes of letters went to members who aren't getting High Holiday tickets. 60 families are 2 quarters or less behind in dues. 19 letters went out to families who have not paid any dues this year. [Of these, 11 have paid no dues AND owe school.] 79 letters in total. This is a lot more than usual, but is because holidays are a lot earlier. We are not picking up new members as we have in past years. We are at 437 members – 307 DPE

J.Marcou: when was the last time a member joined? About 1 month ago.

M.Gaynor: how many DPE's is our budget based on? 299.

Treasurer's Report [M. Dillman]

Preliminary year-end info distributed. We have substantially more money rec'd, but there is still a lot that needs to be posted. Most numbers will be corrected by next month. We had forecast \$1,100,000.

Right now we're at about \$1,040,000. After nursery adjustment, we should still be ahead of forecast. Expenses will be better also. We will likely be in better condition than we had said at budget time last year. Forecast \$65,000, probably end up at about \$85,000.

- J. Edley: where's the \$2,000 that the Men's Club gave? It's reflected.

Planning process ongoing. Board meeting next Monday. First fundraiser – High Holiday cards/flowers. We are taking the money we raise and turning it back into needed things. Gift shop. Israel relief fund. We are looking in to combining the gifts that B'nai Mitzvoth get. Maybe get something made in Israel. Deb Spigner looking into it. Possibly giving Eitz Chaim Chumash instead of three separate gifts. Rabbi concurs that we should come together to give a much more appropriate gift. C. Gittleman: can we have a rep from sisterhood? We already have those channels set up. Cheryl Goldstein. Marc Dillman (on behalf of Marcy): please buy flowers.
